Year 3 and 4 – Residential Trip to Hooke Court 2020

We are delighted to tell you that this year's Residential Trip for Year 3 and 4 will be to Hooke Court. The visit will be from **Monday 15 June 2020 - Wednesday 17 June 2020**. The children be leaving by coach from school after registration on Monday morning and return to school by 2:30pm on Wednesday; traffic permitting. The children will need to bring a packed lunch with them on the Monday.

Hooke Court, in Dorset, is both a field study and activity centre and is truly inspirational. Hooke Court is a 14th century Manor House. These historic characters are used to their full potential to enhance the expansive range of educational programmes and activities that they offer. Each group is treated individually and time is taken to tailor a programme to meet the specific needs of the visit.

The trip to Hooke Court will be designed to create exciting experiences for your children to coincide with the International Primary Curriculum (IPC) that is taught at Parkfield. The children will learn about the environment around them through workshops and understand the importance of team building through challenging activities. All activities will be supervised by Hooke Court tutors with a wealth of experience and knowledge from primary to GCSE level as well as Parkfield teaching staff who will be accompanying the children.

Closer to the time, we will arrange a meeting for parents and students in Year 3 and 4 to find out more about the visit.

The cost of the trip is **£184** per child; this covers the journey to and from Hooke Court, the activities which will be taking place and all meals throughout the visit. If you would like your child to participate, please sign and return the attached reply slip **to the class teacher no later than Friday the 29th November 2019**. All payments must be made through Wisepay via the school website and within the timescale provided. Please note that all payments are non-refundable.
